

## The 2026 Arrigo Recordati International Prize for Scientific Research

# SUBMISSION AGREEMENT

The undersigning herein:

1. Represents to have proper and full rights and powers to participate in the Prize for Scientific Research Arrigo Recordati as an authorized representative of the institution to which the submitted project refers (the "Institution");
2. Represents that all the information, data, and details of the Full Application are complete and accurate and agrees, also for the Institution, to provide further information on the project should such be requested in writing by the Review Committee;
3. Understands and agrees that the Review Committee may ask the opinion of independent reviewers selected for their expertise in the specific area of the project (the "Experts");
4. Understands and agrees that the awarding decision is made by the Review Committee at its discretion and is final and that the Review Committee and Recordati S.p.A. have no responsibilities to any applicant not awarded the grant;
5. Understands and agrees that the Review Committee and Recordati S.p.A. (and, if applicable, the Experts eventually asked for an opinion) have not and will not have / receive any right or title to the results, data, intellectual property (and the like) arising from or, in any event, relating to the project;
6. Agrees also for the Institution that, if the submitted project is awarded with the grant:
  - the grant amount will be credited to the Institution, that will be the sole beneficiary of such a grant amount;
  - the grant amount will be invested in / allocated with the performance of the awarded project;
  - Recordati S.p.A. should be provided with a brief written final scientific report confirming the closure of the awarded project and summarizing the results; and
  - There will be no institutional indirect costs (e.g., overhead costs) added or subtracted two\from the grant. However, if there is a requirement for an indirect cost payable to the institution, a special request must be made to Recordati S.p.A. explaining the special circumstances. If approved, the maximum indirect rate would be 10% of the Prize.
